## 4. FIRST AID MEASURES

## 5. FIREFIGHTING MEASURES

---

Suitable Extinguishing media: Water spray, foam, CO<sub>2</sub>, or dry chemicals may be used in areas where this product is stored.

## 6. ACCIDENTAL RELEASE MEASURES

---

In Case of Spill: Evacuate the spill area, except for cleanup personnel. Wear NIOSH/MSHA-approved respirator and protective equipment. Control spill with adsorbent pads or booms. Recover free liquid. For recovery or disposal, add inert absorbent (sand, earth, sawdust, etc.) to spill area and shovel into containers for disposal. Product is slippery under foot; flush smooth surfaces thoroughly.

## 7. HANDLING AND STORAGE

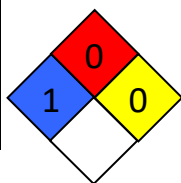
